**ORDER**

**WHEREAS**, Netaji Subhas Institute of Education, Plot No.- 106, Vill- Pokhari, P.O. - Bhillai Pahari, Tehsil/Taluka- Golmuri Cum Jugsalai, Town/City- Jamshedpur, Dist.- Purba Singhbhum, Jharkhand – 831012 (ERCAPP421) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2012-2013 vide ERC order dated 12.06.2012, followed by revised recognition order issued on 29.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61137 dated 05.08.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 05.08.2019. The Appellate Authority vide order No.89-354/E-134881/2019 Appeal/33<sup>rd</sup> Mtg.-2019/21<sup>st</sup> November, 2019/85798 dated 05.12.2019 remanded back to the ERC with a direction to consider the documents to be submitted to them by the appellant and take further action as per the NCTE Regulations, 2014. The appellant is directed to forward to the ERC the documents submitted in the appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS**, the ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> – 20<sup>th</sup> December, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 31.12.2019 to the institution. Another letter dated 15.01.2020 issued to the Circle Officer, Mango, East Singhbhum, Jamshedpur, Jharkhand has requested to physically verify the infrastructure and instructional facilities.

5. **AND WHEREAS**, the institution submitted reply vide letter dated 14.01.2020 received in this office on 15.01.2020. Also, an enquiry report vide letter no. 98 dated 24.01.2020 received from Circle Officer, Mango. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and decided as under:-

**“Restoration of recognition order of B.Ed. course to be issued”.**




