**30. Other items:**

- (i) The Vice-Chancellor informed the House regarding discrepancy in uploading marks of some students of +3 6<sup>th</sup> Semester Online Examination (Political Science), 2021 of R.N. College, Dura (Ganjam) in university portal by the College authorities. The Principal agreed to have committed the mistake and gave in writing that he made a mistake and acted under duress. The guest faculty of the concerned subject Ms. Namita Pattnaik also should have ensured verification of marks entered by the college on results portal. She did not inform the Controller of Examinations of Berhampur University on such an important and sensitive issue. The syndicate admonishes both for such negligence in examination and results related work. The Syndicate decided Dr. Pinaki Mohanty, Principal be debarred from undertaking any examination related to assignments for next two years from the date of issue of this resolution.

The Syndicate also resolved that the results of the students be declared after considering original marks as awarded by the teacher concerned in the subjects. (Controller of Examinations).

- (ii) The Vice-Chancellor informed the Syndicate that the School of Pharmaceutical Education and Research (SPER), a self-finance 2-year M.Pharm. course is still to get Pharmaceutical Council of India (PCI) approval, even though SPER started in the year 2009. As a result, during the recent NAAC application, M.Pharm. course was not accepted and recognised by NAAC. Although the University has been in the process of PCI approval application since 2015, it had to register fresh again in 2021. It was also informed to the house that, although SPER started as a self-finance M.Pharm. program, more than 125 PhDs and 7 DSc degrees have been awarded by the University, supervised by regular faculty members of other departments and contractual faculty of SPER. The University should have been more careful to warn the faculty members not to have conducted PhD and DSc programs, where PCI approval is yet to be obtained even for M.Pharm. program. To streamline the viability and way forward of SPER, a committee consisting of Prof. P.K. Mohanty, Chairman, PG Council and Syndicate member as Chairman and members, Prof. B.B.Panda, Retd. Professor of Botany, BU, Prof. Usharani Acharya, Retd. Professor of Zoology, BU and Prof. J.Panigrahy, Department of Biotechnology, BU, and Dr. P. Gouda, Director, SPER (Convenor) is constituted, which shall submit their report within a period of three months to the Syndicate for further consideration.
