IV. ELIGIBILITY:

The candidate must fulfil all the eligibility conditions given below:

She / he must be a Graduate in any discipline from any recognised University/Institute. General candidates should have at least 50% marks in aggregate in the Bachelor's Degree Examination and SC, ST, SEBC and PH candidates should have 45% of marks in aggregate in the Bachelor Degree Examination.

CASTE CERTIFICATE:

In case of SC, ST and SEBC candidates, the Caste Certificate should be issued by the concerned Tahasildar/Additional Tahasildar from the permanent residential address of the candidate. The Caste Certificate shall be considered by virtue of birth only (Caste by marriage or adoption will not be considered).

V. ADMISSION CRITERIA/ SELECTION PROCEDURE:

Selection of the candidate will be made on merit basis based on Written Test and Career Marks from HSC/10th onwards as per university norm. The Entrance Examination of P.G. Women's Studies will consist of multiple-choice type questions with 1 mark for correct answer and 0 for wrong answer (no negative marking). The answer will have to be marked on OMR sheet as per instructions given in the sheet. The paper will be 90 minutes duration with 70 multiple choice questions from General Knowledge and Social Sciences).

VI. FEE TO BE PAID ALONG WITH THE APPLICATION FORM

Candidates seeking admission into the above course are required to pay a Non-Refundable Fee of Rs. 1,000/- (Rupees One Thousand) only for General Category candidates and Rs. 800/- (Rupees Eight Hundred only) for SC/ST/PWD candidates towards the Entrance Examination and Application-cum-Processing Fee. VIII. SUBMISSION OF APPLICATIONS FOR ADMISSION

Candidates are required to submit full information and upload the required documents through the above Google Forms link by 30 AUGUST 2022. No hard copy of the application shall be accepted in person. The application received beyond the stipulated date shall be summarily rejected.

IX. ADMISSION PROCEDURE

After completion of the process of selection, the Merit List and the Waiting List shall be uploaded in the University website and Intimation Letters shall be communicated to the individual candidates through Email.
