This is for information of all concerned that the 24th Convocation of Berhampur University is scheduled to be held at 11.15 a.m. on 29th March 2023 (Wednesday) in the Biju Patnaik Auditorium, Berhampur University, Bhanja Bihar for conferring and awarding all Degrees and Diplomas for the year 2022. The candidates those who have qualified and eligible for being admitted to degrees in Ph.D., D.Sc. and D.Litt. (Notified from 01.02.2022 to 15.03.2023) will be conferred and awarded degrees. All such bona fide candidates qualified/eligible for being admitted to Ph.D., D.Sc. and D.Litt. degrees are required to apply in the prescribed format along with the requisite fee of Rs. 450/-(Rupees four hundred fifty) only deposited through SB Collect/Bank Challan at SBI/Canara Bank, Bhanja Bihar Branch. Such applications complete in all respects should reach the office of the Registrar, Berhampur University on or before 22nd March 2023.

Further, candidates who will be admitted to the degrees of Ph.D. are required to attend in person at the Senate Hall of the University between 10.00 a.m. and 3.00 p.m. on 28th March 2023 (Tuesday) to receive their respective degrees.

The candidates who will be admitted to the degrees of D.Sc. and D.Litt. are required to be present in the University Auditorium by 10.30 a.m. on 29th March 2023 (Wednesday) for being admitted to the degrees by the Hon'ble Chancellor in person on stage.

The Ph.D., D.Sc. and D.Litt. candidates who intend to attend the convocation in person are required to visit University Central Stores on 28th March 2023 during office hours (10.00 a.m. to 5.30 p.m.) to receive the convocation jackets/robes on payment of Rs 1,300/- (Rupees One Thousand Three Hundred) only in cash, which is refundable after surrender of the same immediately after the convocation is over on 29th March 2023. They are also required to deposit Rs. 700/- (Rupees Seven Hundred) only separately through SB Collect/Bank Challan at SBI/Canara Bank, Bhanja Bihar Branch towards service charge (non-refundable).
