

THE ENGAGEMENT WILL BE MADE AS PER THE FOLLOWING GUIDELINES.

Persons who have retired from the Government / University service on attaining the age of superannuation and below the age of sixty five years having good service records and physically fit shall be considered for re-engagement on contractual basis with a consolidated remuneration.

1. The selection will be governed by the procedure and rules laid down in the General Administration Department, Odisha Resolution No. 23750/Gen dated 27.08.2014 with subsequent amendments from time to time if any.
2. The monthly remuneration will be fixed as per Memorandums issued by the Finance Department, Government of Odisha.

The re-employment shall be made initially for a period of 01 (one) year from the date of their joining and can be extended for subsequent periods subject to satisfactory performance but not beyond the age of sixty five years or till the vacancies are filled up by usual process attached to that post whichever is earlier.
