All payments should be made on on-line basis using SB Collect/ SBI/Canara Bank Challan.

While depositing the examination fee, the college where separate centers are allotted shall retain @ ₹ 70/- (Rupees Seventy) only per candidate towards Centre Expenses and the Departments and Colleges are attached to the P.G. Council for the conduct of the said examination shall deposit the whole fee without any deduction towards Centre Contingency in the General Fund Account of the University . The Controller of Examination shall provide the Centre Contingency Expenses basing upon the actual strength of the students to the Chairman, P.G.Council through the Comptroller of Finance. The unspent amount should be refunded to the University immediately after the completion of the Examinations.

**GUIDELINES FOR ON-LINE FORM FILL UP :-**

1. The on-line form fill up of the eligible students as per the Regulations for the ensuing **P.G.2<sup>nd</sup> Semester (CBCS) Examinations-2023** shall be done by the Colleges/P.G. Departments through the link <https://berhampuruniversity.siliconteclab.com/buerp/build/index.php>. All further advice in this regard shall be sent through college E-Mail ID only. All eligible students shall have to fill-up the prescribe application form (Stream wise, and Semester wise) as issued by the College and submit the same to the College for further follow up action at their end. All subjects as chosen by the student's viz. Core/Elective/CBCT should be registered correctly.
2. No Application form for the P.G. 2<sup>nd</sup> Semester (CBCS) Examinations 2023 shall be accepted after the schedule date.
3. The Chairman, P.G.Council, Berhampur University and respective Principals/Head of the Institution where the Examination Centres are fixed shall act as the Centre Superintendent. Any alteration in this regard shall be acknowledged to the undersigned for further approval.


