369. Considered the Proceedings of the Joint Meeting of the Discipline Committee and P.G. Council held at 2.00 p.m. on 12.10.2018, which discussed regarding the *sine die* situation in the University Campus, duly forwarded by the Chairman, P.G. Council vide Letter No. 1513/PGC dated 12.10.2018.

**Resolved that:** Basing on the recommendations of the Discipline Committee and P.G. Council, the orders of *sine die* be revoked with effect from 13<sup>th</sup> October 2018 as the situation in the University Campus is peaceful. Further resolved that the hostels of the University be opened for the boarders from the reopening day after Puja Vacation i.e. on 26<sup>th</sup> October 2018 as there are damages to these buildings, disruption in supply of electricity and water due to the recent severe cyclonic storm *Titli* as reported by the Warden, P.G. Hostels.

370. Ratified the Proceedings of the Meeting of the Discipline Committee held at 11.00 a.m. on 05.10.2018 and the Proceedings of the P.G. Council held at 4.00 p.m. on 05.10.2018 with regard to the ceasing the studentship of Mr. Ajit Swain, a student of Part-II, J & M.C.

371. Considered according Administrative Approval for Rs. 1,50,00,000/- (Rupees one crore fifty lakh only) to meet the probable expenditure towards repair/ renovation of the damaged roads, buildings, electrical installations and PH fittings that caused due to the recent severe cyclonic storm *Titli* on 11<sup>th</sup> October 2018.

**Resolved that:** A proposal be submitted to the Special Relief Commissioner, Odisha to consider sanction of a special grant of Rs. 1,50,00,000/- (Rupees one crore fifty lakh only) to undertake repair/renovation works for restoration of the University to the pre-Cyclonic condition.
