(iii) In case of Political Science, the candidate, namely, Dr. SHARADA PRASANNA ROUT has been recommended by the Syndicate for appointment against the post reserved under PWD (VH) category from among the candidates appeared under the same category in different subjects advertised vide Advertisement No. 4432 & 4434/Adm-I (TE) dated 22.5.2017.

Further, Dr. Rout is required to appear before the Standing Medical Board and produce the PWD (VH) Certificate within a period of one month or within seven days from the date of issue of such Certificate, whichever is earlier, failing which he will forfeit his candidature and the candidate recommended by the Selection Committee under UR Category be given appointment. A letter to this effect be issued to the candidate under intimation to the CDMO, Ganjam, Berhampur.

- (iv) As the single eligible candidate called for the Interview for the post of Lecturer/ Assistant Professor (Stage-1) (ST-1) in Computer Science has not turned-up before the Selection Committee, the Interview could not be conducted.
