Further, as per the recommendation of the Committee, examinations can be conducted in the College and Sri Pani can be entrusted the duties of Centre Superintendent for future examinations of the University (Action: Controller of Examinations).
- (ii) Considered the request letter dated 6.2.2020 of Sri Nilanchala Sethy, Guest Faculty, Lingaraj Law College, Berhampur. It was decided to entrust examination duties and responsibilities to Sri Sethy in future (Action: <u>Controller of Examinations</u>).
- (iii) In consonance to the ban imposed by the Government on sale and use of Tobacco items like Cigarette, Ghutka, Pan, etc. it is decided to completely ban sale and use of these items in the University Campus. It is observed that some such consumers are spitting and creating unhygienic conditions. Appropriate action be taken against the offenders.

 Further, it is also observed that a couple of employees are under influence of alcohol and attending office, which is a major offence. A notice be issued to all concerned to refrain from such activities and severe punishment as deemed fit will be imposed on them, if the order is violated. (Action: Adm-II (NT))
- (iv) The Govt. in the Department of Higher Education, Odisha be moved to give permission to fill-up all existing vacant Group-A and Group-B non-teaching posts. (Action: Adm-II (NT))
