- (ii) To make the SPER self-sufficient, the course fees may be enhanced by 20% from the academic session 2020-21 i.e. Rs. 60,000/- per year. However, this will be effective to the first year students taking admission in the academic session 2020-21 and not to the 2nd year students taking readmission in the academic session 2020-21.
- (iii) To recruit one Professor with a Remuneration of Rs. 60,000/- per month and three more Lecturers with a Remuneration of Rs. 21,600/- per month each.
