1. The tenderer must be a Registered dealer under GST Act.
2. The tender must be clearly written or typed without any cancellation /correction/overwriting.
3. The Tender Form with terms and conditions must be submitted with seal and signature
4. The rate should be quoted for the specified items only
5. The tenderer should not quote any other specification, which differs from the specification given.
6. The rate should remain valid up to 31-03-2022
7. The tenderer must be a manufacturer or direct agent /dealer of the manufacturer
8. The rate should be for Berhampur University basis and inclusive of all Govt. Levies, taxes etc.
9. The rate should be inclusive of packing and forwarding charges, insurance, and other incidental charges.
10. Prices quoted must be in Indian rupee only and in case of foreign equipment the tenderer may quote in foreign currency.
11. In case of foreign equipment, the address of principals/manufacturers and their Banker's details should be furnished. In case the bidder is an Indian agent of the foreign manufacturer, he has to submit authentic certificate of the manufacturer. Also, the bidder has to take all responsibility to deliver & demonstrate the instrument at Berhampur University & the bidder has to quote accordingly.
12. Deliver period of each item should be mentioned. Ex-stock delivery will be preferred.

13. If the delivery is not made as per agreed terms and condition by the bidder, the purchaser will have the right to procure the goods from alternatives as he may think fit and can claim the difference in rates and all related expenses, if any from the bidder and in such a case the amount deposited as EMD will be forfeited.
14. The Registrar will be the final authority and his decision will be binding, in case of any dispute or complaint regarding the tender or purchase.
15. Cost of the Tender paper is **Rs. 500/- (Rupees Five Hundred Only)** and EMD of **Rs. 3,000/- (Rupees Three Thousand Only)** should be deposited in shape of Bank draft drawn in favor of **PRINCIPAL INVESTIGATOR, OURIIP SEED FUND 2020, OSHEC, Govt. of Odisha Project NRMG**, payable at **CANARA BANK, Berhampur University Campus, (Code 6371)** or any other bank otherwise the tender will not be accepted.

18. All disputes pertaining to this tender are subject to exclusive jurisdiction of competent court in Berhampur /Odisha High Court only.
19. Details of onsite warranty, agency that shall maintain warranty & under take AMC/comprehensive Services contract beyond warranty shall be given in the offer. In case of foreign quote, the Indian agent who shall remain warranty & AMC beyond warranty shall be given in the offer. Name, address, contact person, phone/E-mail etc. of such firm may also be indicated clearly.
20. The items should be supplied with manuals including technical drawings to operate the system without any problem.
21. The supply of spare parts is to be guaranteed at least for a period of 10 years after supply of the equipment.
22. Indicate the names of the customer where similar equipment was supplied and may attach the satisfactory performance report.
23. The tenderer has to state in details the Electrical power/UPS/stabilizer requirements, room foundation needed and also to state whether Air Conditioned environment is needed to house the system etc. & to run the tests i.e. pre-installation facilities required for installation in the offer.
24. The form must submit Xerox copy of valid GST clearance certificate otherwise the tender will not be accepted.
