TERMS AND CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the selected service provider at the time of providing the vehicle

- 1. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, valid contact carriage permit, prove of up-to-date tax payment etc. which are mandatory for paying of vehicle.
- 2. GST registration is compulsory for any service provider to provide the vehicle to Government Office.
- 3. The driver of the vehicle must have a valid driving license for Light Transport passenger and should be sufficiently experienced in driving transport passenger vehicle. It shall be the responsibility of the service provider to provide a driver with well behaviour, gentle, sociable and obedient. The salary of the driver shall be borne by the service provider.
- 4. In case of breakdown for whatsoever may be the reasons replacement of a Vehicle of the same or better model shall be provided by the service provider.
- 5. In case of the Vehicle do not report regularly the authority will be at liberty to cancel the agreement at any given point of time and may engage Vehicle from other source.
- 6. The Vehicles shall report for duty for a minimum 26 days in a month
- 7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded by the service provider.
- 8. The hire charges do not include fuel cost which is to be paid separately based on the actual consumption of fuel and lubricants as per existing government norms.
- 9. All the expenditure of the vehicles towards repair/replacement of spare parts etc. will be borne by the service provider.
- 10. If the service is not satisfactory or if the service provider intends to withdraw the vehicle, in either case the agreement can be terminated with one month notice.
- 11. After completion of the tender process, the successful service provider has to sign an agreement;
- 12. The envelope with super-scribing "QUOTATION FOR HIRING OF VEHICLE' containing the quotation be submitted along with the copies of the following Documents duly signed by the service provider and must be addressed to the Registrar, Berhampur University.
 - a) Valid commercial registration certificate
 - b) I.D. Proof and driving license of the driver (Aadhar Card)
 - c) Up to date road tax payment receipt
