**TERMS AND CONDITIONS**


1.	The bidder must be a registered dealer under GST Act with valid PAN (submit Xerox copy) and should have expertise in this field. The bidder should submit the proof of executing similar work orders and its completion certificates, which will be considered under past performance.
2.	The Expression of interest proposals /quotations must be clearly written or typed on the letter head without any correction/overwriting.
3.	The EoI proposal with detailed layout, plan and terms & conditions must be submitted with seal and signature.
4.	The EoI proposal is two bidding system. The technical bid and price bid should be submitted separately in a sealed envelope. Both the bids along with desired documents should be packed in another envelope. The rate should be quoted for the specified items only. The tenderer should quote fulfilling atleast minimum requirement as described separately.
5.	The bidder must be a manufacturer or direct agent /dealer of the manufacturer.
6.	The concerned vendor should visit physically for above purpose, preparing Master Plan and the Vendor must do PowerPoint presentation before the Technical Committee for clarification. The Financial Bid will be opened only after satisfactory presentation before the technical committee, and successful recommendation by the Technical Committee.
7.	The rate should be inclusive of all Govt. Levies, taxes etc. The rate should be inclusive of packing and forwarding charges, insurance and other incidental charges. The entire project will be executed on turnkey basis.
8.	<p>A. 9.	Prices quoted must be in Indian rupee only.
10.	Execution period will be maximum of 90 days from date of issuing the order.
11.	If the work is not executed as per agreed terms and conditions by the bidder, the purchaser will have the right to cancel the order at any point of time during the execution of the work. The EMD and performance security amount will be forfeited.
12.	The Registrar of the University will be the final authority and his decision will be binding and final. In case of any dispute or complaint arising from or tender or any part thereof. The authority has the liberty to cancel the entire bidding process.
13.	Cost of EoI paper is Rs-5,000/-, and EMD will be 2% of the quoted price. Both EoI paper cost and EMD should be deposited in shape of Bank draft drawn in favour of 'Comptroller of Finance, Berhampur University' payable at SBI, Bhanja Bihar Branch. The performance security will be 5% of the quoted price and will be released after successful completion of the work as well as after the warranty period.
14.	The EMD of successful bidder will be returned only after supply and satisfactory installation of the items. The EMD of unsuccessful bidders will be returned immediately.
15.	The total payment with respect to the cost of the project will be made soon after completion of the project and /or handing over the project to the official concerned including the supply of equipments in Good condition & satisfactory installation, commissioning, training hereof (wherever required ).
16.	All disputes pertaining to this tender are subject to exclusive jurisdiction of competent court in Berhampur / Orissa High Court only.
17.	Details of onsite warranty, agency that shall maintain warranty & under take AMC/ Comprehensive Service Maintenance contract beyond warranty shall be given in the offer. In case of foreign quote, the Indian agent who shall remain warranty and AMC beyond warranty and AMC shall be given in the offer. Name, address, contact person and phone/fax number/ Email id etc. Of such firm may also, be indicated clearly.

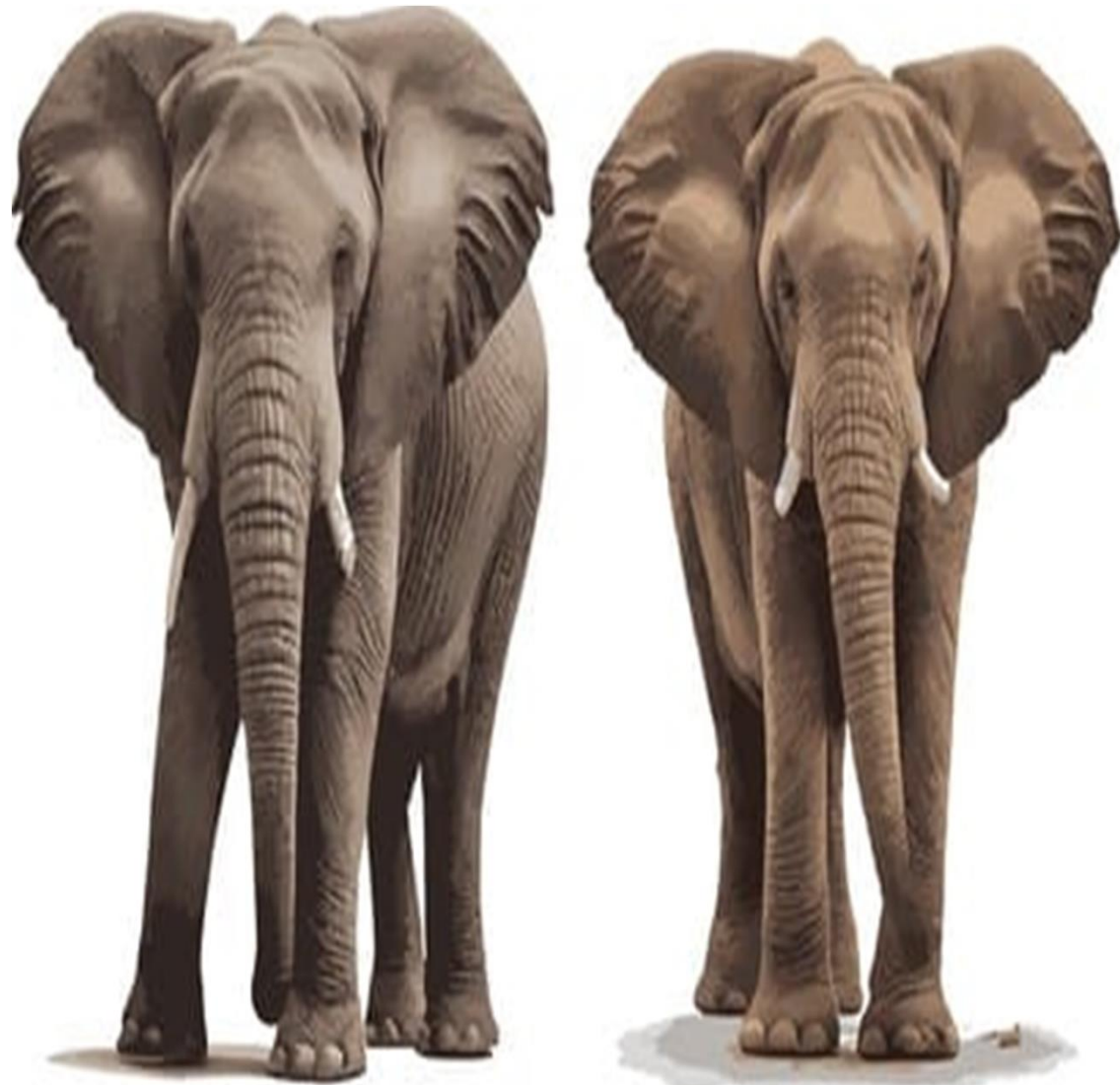

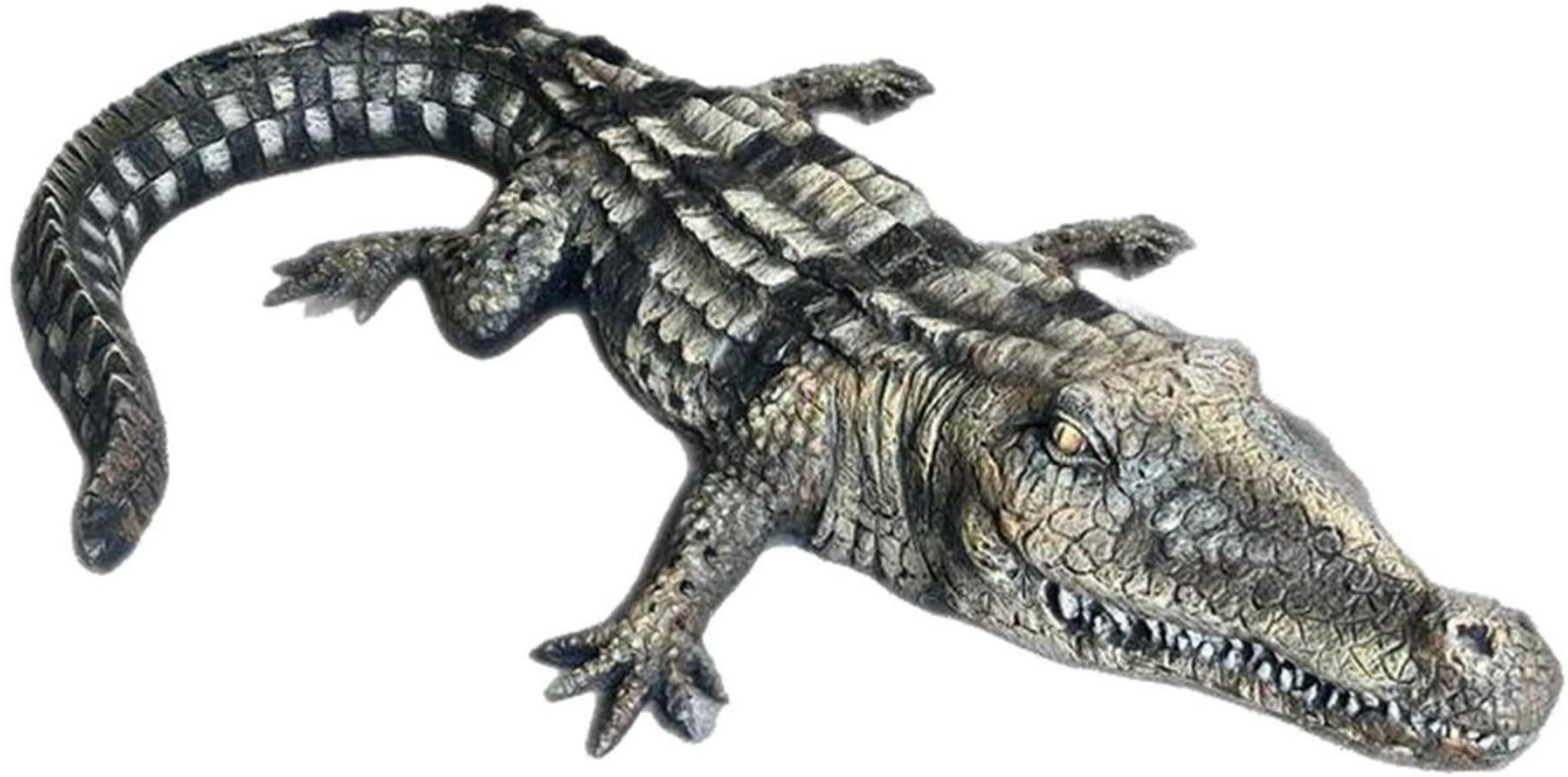
