- Conditional and Bids without crucial information / with supporting documents will be rejected
- 3. All the bids will be scrutinized by a committee constituted by the university.
- 4. Upon scrutiny of offers in all aspects and fulfilment of all documents, the bid acceptance letter will be awarded to the best and highest quoted responsive bid.
- Pick and choose method of collection shall not be allowed. The approved bidder is obliged to lift all scraps including the waste materials / items for which no rate is offered/ quoted.
- 6. Bidders are advised to inspect the scraps under auction sale and satisfy themselves regarding the nature/ description / conditions / encumbrances/ lien/ charge/ statutory dues etc. over the property before submitting their bids.
- 7. Statutory dues/ liabilities / taxes etc. due to the Govt/ Local body shall be borne by the purchaser.
