



Instructions for Online Mode of Examinations

1. The Examination will be held as per the programme (Theory & Practical) even if any of the date is subsequently declared as holidays. No requests for change in examination shall be entertained.
2. The Centre Superintendent(s)/ HODs/Principals are required to notify the subjects of the examination papers to the candidates well in advance of commencement of examination taking into account the subject code as mentioned in the programme.
3. All the Heads of the Departments/Principal of colleges are required to create group E-mail/Whats App group of the eligible students well in advance, i.e. prior to fifteen days of commencement of the theory examination. If possible a mock test should be conducted by the concerned teachers.
4. The question paper shall be relayed to students fifteen minutes prior to commencement of the Examination through E-mail/Whats App by the Principal/Course Coordinator.
5. After completion of the examination, the students must send a scanned copy of the answer script to the E-mail/Whats App of the teacher concerned with a copy to the Head of the Department/Principal within 30 minutes of completion of the examination. Further, after completion of all the Examinations, the students must also send hard copies of all answer scripts by post to the concerned Head/Principal.
6. The concerned Head of the Department/Principal shall take steps for conduct of the Practical Examinations as per UGC guidelines through Skype or other meeting apps in consultation with the C.O.E, or in the form of written online examination.
7. The Viva-voce component of the final examination in dissertation/project work/seminar and practical examinations (if any) etc., shall be conducted online or other meeting apps, and the final marks shall be submitted to the C.O.E. at an early date, so as to publish the result at the earliest possible.
