## **Faculty Members**

Applications along with Bio-data and copies of testimonials are invited from intending candidates, for two posts of Faculty Members (on contractual basis) in consolidated pay of Rs.35,000/- as per conditions of service given below to impart training on various subjects of law to the Judicial officers and other participants during Induction / Refresher and other training programmes during their tenure. Out of the two posts, one faculty member has to be an academician. He / She should be preferably a retired Professor in Law from any recognized University. Other faculty member should be retired District Judge Cadre Judicial officer having experience in teaching/imparting training. The candidate desirous to apply for the post must be willing to attend the Academy on Sundays/holidays in which training programme is scheduled to be held.

### **Eligibility Conditions:**

- (i) Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re-employment against the above posts.
- (ii) Officers against whom departmental proceedings or criminal cases are contemplated / pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

#### **Assignment:**

To impart training on various subjects of law to the Judicial Officers and other participants during Induction/Refresher and other training programmes during their tenure. No holiday on which the training programme is to be held should be availed by them.

### **Selection Process:**

(i) Selection of persons will be made by Selection Committee as may be constituted by the Hon'ble Chairman of the Odisha Judicial Academy & Training Committee.

#### **Tenure, Terms & Conditions:**

(i) The re-employment shall be made initially for a period of one year and can be extended for subsequent period with spells of one year each subject to satisfactory performance up to a total period of four years not beyond the age of sixty-five years of age in any

- case or till the posts are filled up by regular process whichever is earlier.
- (ii) Re-employed officers will be entitled to consolidated pay of Rs.35,000/- p.m.
- (iii) Re-employed officers shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (iv) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one-month notice. On the contrary, if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.

## **Last Date for receipt of application:**

The application for the above two posts must be received in the office on or before 17.10.2019. Any application received after the prescribed last date shall be summarily rejected. A Walk-in-Interview shall be conducted on 18.10.2019 by the Hon'ble Judicial Academy & Training Committee in the Old Conference Hall of the Heritage Building, OHC for the purpose of selection of above Faculty Members.
