- **2.** Bids will be awarded to bidders quoting the lowest price separately for each Bare Act. Percentage of discount / value of discount to be offered must be mentioned specifically.
- **3.** The rates quoted by the bidders once accepted shall be final for delivery of books.
- **4.** The price quoted must be inclusive of taxes and charges including transportation and handling charges. OJA will not pay any additional charges.
- **5.** The intending bidders must have adequate stock to supply the Bare Acts within 10 days from the issuance of work order.
- **6.** Damaged or misprinted Bare Acts to be replaced immediately without any additional cost and if the bare acts found defective at the time of actual use, must be replaced at once. Hence, all the bare acts must be covered under a free replacement condition till their actual use.
- **7.** The bidder must supply the latest edition and latest amended bare acts as per the quantity mentioned in both of the Annexures.
- **8.** The offer once submitted shall remain valid for a period of 60 (Sixty) days from the date of selection of eligible bidder. It shall not be open to a bidder to withdraw the offer after submission of quotation or change the rates quoted and /or the terms and condition of offers during this period of 60 days for any reason under any circumstances.
- **9.** The successful bidder(s) is to raise the bills in triplicate after supply of the ordered quantity.
