### THE ACADEMY

Training the judicial officers in order to equip them to face the challenges of the profession is not simply logical but inevitability for effectively performing the most delicate of functions in the governance structure. The judicial organ of the state has the responsibility to protect the rights of the people and also has the duty to ensure that other organs of the state do not overreach the dimensions of the power as has been vested in them within the constitutional and legal framework.

By its very nature, this function involves confronting friction of various intensities at various levels. Resolution of disputes is never likely to be popular profession as it will always involve having to make difficult yet necessary decisions. Thus, a judicial officer should not only have the backbone of sound legal knowledge and reasoning, he/ she also must have a balanced mind and a committed attitude to deal with the pressures of the profession.

Inability to handle the accompanying pressures is very likely to impair the judicial objectivity and righteous strength of a judicial officer which would consequentially erode the public confidence on the integrity and capacity of the institution.

These pressures and challenges are unique in the life of a judicial officer and the nature of these challenges is likely to vary in different stages of the profession.

Thus it is imperative that judicial officers who are part of this challenging environment are afforded the best possible training and orientation so that they do get strengthened in the face of reality.

This need of training and orientation is relevant not only at the entry level but also as a continuous up-gradation of one's skills and aptitude. The justice delivery mechanism is but a collective of these judicial officers who operate the closest to the socio-political environment of the country. The efficacy of this system is dependent on the collective capacity of the judicial officers to respond to the challenges of our times.

Continuous judicial education and training in a systematic and organized manner are effective tools to increase the efficiency and efficacy of the judicial system.

To upgrade the requisite skills, knowledge and attitude of the judicial officers, the State Judicial Academies have to operate accordingly. The recommendation of the Law Commission in a series of reports culminating in the one hundred and seventeenth report, emphasized the need for continuous judicial education and formulated it's basic aim in the following words:

"The basic aim of training briefly spelt out is to equip the trainees not only with tools to execute their work, but to endow them with vision as to what is expected of the system which they serve. What is meant by Justice? What is decision making process? What are the goals of the Constitution? What is the direction in which law must move? What does the dictum justice according to law imply?"



In the All India Judges' Association Case (AIR 1992 SC 165) and in the order on the Review Petition (AIR 1993 SC 2493), the Supreme Court declared the urgent need to organize judicial education on a systematic basis through National and State Judicial Academies. Then, the Supreme Court in a more recent case i.e., All India Judges Association V Union of India {(2002) 4 SCC 247} laid emphasis on in-depth training for Judicial Officers.

At the turn of the century, the training programme for judicial officers was in a marginalized state due to want of proper space and infrastructure. The most helpful training at that stage was perhaps the experience a newly appointed judicial officer earned by sharing the dais along with Senior Judges to observe day-to-day proceedings in the Court. Useful as it may have been, it was training under personalized guidance without any institutional capacity building. The values which should underline the framework of training were not adequate institutionalized.

A decision was made by the Hon'ble High Court of Orissa on 30.03.2001 to establish a Judicial Academy to enhance the learning and training to be imparted to Judicial Officers in the State of Odisha. The vision was to provide a platform to Judicial Officers so that they could be enabled to strive for excellence in their endeavour to dispense justice. The decision was implemented by the State Government by establishment of a permanent Judicial Academy for Odisha at the old building of Board of Revenue, Cuttack. On 02.04.2003. It was in this background Odisha Judicial Academy came into existence on 20th December, 2003. The Odisha Judicial Academy was inaugurated on 20th December 2003 by Hon'ble Dr. Justice A.Pasayat, Judge ,Supreme Court of India, in presence of Hon'ble Shri Justice Sujit Barman Roy ,Chief Justice of Odisha,& Dr.N.R. Madhava Manon ,Director National Judicial Academy, Bhopal with the objective of imparting training to newly recruited judicial officers as well as for in-service judges and others. The inaugural function was attended by Hon'ble Judges of High Court of Orissa, District & Sessions Judge, Registrar General, High Court of Orissa, Principal Secretary Law, Govt. of Odisha and Officers from District Judiciary.

The training programme has different components like field training, aptitude orientation, development of judicial attitude and awareness of ethical conduct in addition to the strengthening of legal knowledge and reasoning. The Academy has developed customized training programme not simply for newly recruited Judicial Officers & inservice Judicial Officers but has also designed refresher programmes for other state holders like Public Prosecutors, members of Juvenile Justice Board, Police Officers, Mediators, Conciliators, Court Managers & others.

Within a decade, the Odisha Judicial Academy has been able to provide new dimensions to the training of judicial officers which earlier were unexplored. Now all judicial officers joining the Odisha Judicial Service undergo a planned and systematic training programme which is oriented to their wholesome development as judicial officers.



### **REFRESHER PROGRAMMES FOR JUDICIAL OFFICERS & OTHERS:**

The first programme was conducted on Child Psychology & Child Welfare for Sr. Judicial Officers; to educate them as to how the developmental psychology one of the Scientific study of changes that occurs in human beings over the course of their life span, during the year 2003-04.

Two programmes for Counselors, Conciliators and Newly Recruited Judicial Officers (1st Batch) were conducted in the year 2005.

The resource persons for the above programmes enlighted the participant Judicial Officers about "Conciliation is an alternative dispute resolution (ADR) process whereby the parties to a dispute use a conciliator, who meets with the parties separately in an attempt to resolve their differences".

Since the in-service officers have got already some experience in disposal of the cases, their experience were shared in interactive sessions. But in order to give shape to their mind set, they were sanitized more in substantive law than the procedure law. So, the subjects relating to adjudication management in Civil, Criminal cases, Environmental Law cases and other laws relating to marginalized community were undertaken. Further they were addressed more in Constitutional Justice by resorting to poverty, Social Exclusion, Eelfare Programmes, Access to Justice, Struggle for Equality, Social change, Economic Justice & Social Justice.

In every month one or two programmes were held. Each programme consists of eight sessions and each of the sessionhas span of 1 hour 15 minutes.

## INDUCTION PROGRAMME FOR NEWLY RECRUITED JUDICIAL OFFICERS (2003-2013)

In accordance with the Induction Training modules, newly recruited Judicial Officers for the year 2004, 2009 to 2013, have undergone Training for one year out of which six months at Academy, three months at the field and last three months again at Academy. Each day constiting of 5 sessions of duration 75 minutes with usual Tea and Lunch Break. The Trainee Judicial Officers shall make presentation of half an hour what they have learnt during the day.

The Syllabus consists of three parts.

- (i) Law, Justice and Constitutional governance: One month.
- (ii) Law, Courts and Administration of Justice: Four months.
- (iii) Administration of Justice vis-a-vis select problems in Society: One month.

As part of the programme the Trainee Judicial Officers were sent to remote villages for interaction, to gather knowledge about common problems, to ensure the social justice and the how for they have got benefitted of justice delivery system. In addition to it, they were sent to Hospital to acquire knowledge about the post mortem and clinical' examination of injuries & to Forensic Laboratories where the Experts share their forensic knowledge with them.

The method of Institutional Training are as follows:

- Presentation, discussion by using LCD Projector.
- Group Exercises and Presentation.
- Case Studies, experience sharing and sharing best practices.
- Mock Trial between the participants.
- Simulation Exercise.
- Participatory learning.
- Learning goals.
- Evaluation & follow up.

Thus the capacity buildings of Judicial Officers are well addressed. In Second Induction Training of same batch, they have been sensitized about the records, cases parties and the problems of society, they experienced and their opinion / difficulty on the same are well diluted.

#### A Decade of Excellence



In order to strengthen the Induction Training Programme, the Academy has recently adopted two years training module for the newly recruited Judicial Officers in the cadre of Civil Judge, Junior Division, suggesting the Govt. of Odisha to ammend OJS & OSJS Rules 2007.

The Academy has also introduced the Induction Training Programme for newly recruited Additional District Judges (from Bar & limited Examination) duration of 6 weeks.

### PROGRAMME FOR PUBLIC PROSECUTORS

Orissa Judicial Academy has undertaken the training programme of Public Prosecutors of the State.

In order to improve the Judicial System and capacity building of Public Prosecutors the training for the Public Prosecutors was felt necessary. So for the first time training for Public Prosecutors was undertaken by Orissa Judicial Academy. Public Prosecutors/Add. Public Prosecutors/Asst. Public Prosecutors have been imparted training on various subjects such as Role of Public Prosecutor, Criminal Justice system & other subjects including Juvenile Justice, Finger Print, Question document, Psychology etc. and in each batch 30 nos. of Public Prosecutors were imparted training as per training modules, on rotation basis. So far, the Acadmy has already imparted training to all PPs, Addl. PPs and Asst. PPs of the State. At present all of them are undergoing II phase training on ratation basis with a view to upgrade their knowledge and skill.

Further, the courts with its widest interpretation in observance of Hunan Rights have contributed to the progress of the nation and played a major role in enforcing the rights.



# SHARING BEST PRACTICES PROGRAMME for Newly recruited Judicial Officers
