- The Registrar, BU is requested to provide space and furniture for the Alumni Association office in the premises of PG department of IRPM.
- The Alumni Association will take necessary steps to register the Association under Societies Registration Act, 1860.
- Head of the all PG departments and the principal of the Lingaraj Law College are requested to activate all the alumni members of their respective departments and motivate them to enroll in the association.
- 10. Necessary steps will be taken to publish all the activities of the Alumni Association in the local Odia newspapers preferably.
