The students are required to adhere to the following guidelines while choosing Open Elective Subjects.

- The students may consult with their Project Supervisor and/or Mentor and give due consideration to the relevance and future prospects while choosing the open elective subject.
- 2. The Open Elective Subjects opted by the students must neither have been offered earlier in the programme nor have any similarity in the course content of any subject of the programme taught so far.
- The Open Elective Subjects originating from a department cannot be opted by the students of that department.
- 4. If the number of students opting for a subject is less than 30, then that subject will not be offered as an open elective.
- 5. In each open elective subject, maximum 120 students will be allowed on the basis of defined criteria and the order of preference submitted by the students.
- 6. The classes of Open Elective subjects may comprise of students of more than one branch.
- 7. Each student is required to submit their choices for maximum five (5) open elective subjects in order of their preferences.
- 8. HODs are requested to give wide circulation of the notice involving Open Elective subjects to the students of respective department through final year faculty co-ordinator / mentors. Final year faculty co-ordinators or Department Time table co-ordinators are empowered to allot open elective Subjects to the defaulter students.
