## Notice regarding conduction of Ph. D course work examination through NPTEL at University level

Mentioned below the resolution made by Academic Council on 03.07.20 with recommendation of RPIC on 23.06.20.

The credit transfer of a student in respect of assignment mark and passed certificate issued by NPTEL authority in wake of Pandemic COVID -19 following the resolution of RPIC, the Academic Council approved the same with a resolution that University shall conduct an examination (MCQ based, online) centrally only for failed students by putting questions from NPTEL pool based on the assignment question.

The credit transfer of such courses is possible if he/she shall have to pass in the examination at the University level under the situation COVID-19. However the examination is optional for the students those who are declared pass by the NPTEL authority based on their assignment score.

Based on the above resolution and as per directive of AICTE in this regard, it is hereby notified that the Ph. D research scholars, who have pursued Ph. D. course works through NPTEL mode (2018 & 19 Admission batch) and declared fail are required to appear a separate examination at the University to be conducted centrally in adherence to the following guidelines.

Publications of result in respect of pass and allowed for credit transfer subject to the following norm.

Examination
Maximum Mark :- 75 Pass Mark:- 30

A student shall be declared pass if he/she shall secure minimum 40% as an average including assignment and examination mark. However students shall have to pass in assignments or else he/she shall not be declared pass and the credit will not be transferred equivalently.

Controller of Examination is requested to take initiative in consulting with NPTEL Coordinators.

The students those who have declared pass based on assignment score by NPTEL authority are instructed to submit their pass certificates along with an application on or before 18.09.20 addressing to Controller of Examination for requesting the transfer of Credit in the concerned subject.
