#### Third Notice on skipping of subjects after the publication of results of Special Examination 2018

As resolved in the Academic Council Meeting held on 26.05.2018, the regulation, notification and practice of the affiliating University (Biju Pattnaik University of Technology), Odisha, Rourkela shall be followed for award of B. Tech. degree after skipping of subjects for the students of 2014 Admission Batch.

A student of B. Tech. programme of 2014 admission batch are hereby informed that they can skip one **Theory Subject** by applying in the prescribed format in the office of the **Dean Academics** as per the following conditions and guidelines.

- 1. A student can skip that (Theory) subject in which he/she has secured 'F' Grade only.
- 2. A student cannot skip a subject in which he/she has passed.
- 3. A student cannot skip in any Sessional, Laboratory, Project, Seminar, Dissertation, Comprehensive Viva Voce subject.
- 4. A student cannot skip one subject in which he/she has 'M' Grade.
- 5. A student cannot skip one subject in which he/she has 'S' Grade.
- 6. A student cannot skip one subject in which he/she has not met the attendance criteria and as such he/she has been debarred in that paper in the last End Semester/Academic Back Examinations.
- 7. A student applying for skipping one subject must obtain minimum credit point in the various categories of subjects as shown below.
