Students must note and strictly adhere to the following instructions.

1. Strictly follow the Academic Calendar for all Academic and Exam Activities.

2. Attendance Requirements:

The students may note the following points with respect to the attendance requirement.

Each student must note that he/she needs to attend at least 75% of the classes held in a subject to be eligible to appear in the Class Test/Midterm/Semester Examinations. A maximum of 10% attendance can be condoned under the following conditions.

i) Medical case/Illness: In this case the student needs to submit the Original medical certificate from a Government Hospital, reputed Private Hospital or Clinic, or a reputed Private Doctor. The prescription must be attached with the certificate. In the medical certificate there must be a recommendation for rest/leave/hospitalization for at least seven days. The student must submit the certificate in a duly filled in prescribed format (Form F-4) within seven working days of resuming classes in the office of Dean Academics.

Medical representation violating any one of the above norms shall be rejected.

ii) Institute Representation: If a student intends to attend any institutional/national/regional/state/Institutional (reputed institutes such as IITs, NITs etc.) level sports/athletic/cultural/technical events then he/she needs to apply in the prescribed format and obtain final permission from the Principal duly forwarded by HOD/Dean First Year. In this case the student needs to submit the certificate of participation or any other document substantiating his/her claim of participation in an event. The student must submit the certificate in a duly filled in prescribed format Form (F-1) with seven working days of resuming classes in the office of Dean Academics.

Representation of the students involving participation violating any one of the above norms shall be rejected.

- A maximum of 10% attendance can be condoned for a student on the two clauses taken together (i & ii) i.e. Medical case/Illness, Institute Representation, Genuine Compassionate Ground. Under any circumstances a student is not eligible to appear in a subject in a Class Test/Semester Examination if his/her attendance up to the last day of calculation for that test/examination is less than 65%.
- Representation of Genuine Compassionate Ground: If a student missed some classes due some genuine problems such as any domestic/family issues, unfortunate loss of parents etc. then he/she must represent his/her problem within seven working days of resuming the college. In this case the student needs to submit his/her grievance in the Office of the Principal in a plain paper as per the guidelines/instructions of Principal.
- iv) For compilation of attendance each class taken between the date of commencement of classes and the closing date of instruction as per the formal time table shall be taken into consideration. Any class taken after the closing date of instruction without prior permission of Principal shall not be considered for computation of attendance percentage.
- v) Additionally the B. Tech students (irrespective of the year) aspiring to participate in the industrial training or internship during the semester for upgrading their industry oriented skill may be sponsored by the institute. Number of such sponsored students shall not exceed 5% of the admitted strength for each branch. Such students shall apply to the office of the Dean Academics in the prescribed form (Institution Sponsored Academic Activity Form-F6) in advance for availing concession in their attendance on pro-rata basis.

- vi) Concession in attendance for the above case shall be limited to 25%. After availing concession in attendance, student's attendance should not fall below 50%. Supplementary classes as per a prescribed time table to be arranged for students of above category who are having less than 50% attendance to cover the course and to make them eligible for examination.
- 3. Each student must register on the dates mentioned above. Clearance of all college dues and registration is mandatory for appearing End Semester Examinations.
- 4. From the Academic Session 2019 20 the examinations for backlog subjects shall not be conducted during the Regular Semester. But examinations of all backlog subjects shall be conducted during the Summer Quarter Examinations (Likely to be held during the month of June).
- 5. Final Semester Course for a Section of Students:

For a (meritorious) section of students a credit transfer system shall be implemented while allowing them to take Component of the 8th semester program in association with Industry as per the following:

- Credit transfer to Industry based Training and project in exchange of Elective (theory and labs), Lab (core), Major Project (stage-3). The regulations involving evaluation and credit transfer shall be developed in accordance with the Grade Equivalence Policy of the institution.
- ii) For the section of students mentioned above, the curriculum for core subjects of 8th Semester be devised from NPTEL, SAWYAM, Institutional e Learning Resources etc. The students can learn the subjects by their own and they will be exempted from attending classes. This is to facilitate the students to carry out the industrial training and project course effectively without hindrance. Same Course Content shall be followed for remaining section of in-campus students.
- iii) Final year B. Tech students may be sponsored for one year/ Semester out of campus for full time industrial training assignments/projects with reputed organizations during 7th and 8th semesters. Such students shall be allowed to skip in-campus 7th /8th semesters or both courses/classes in lieu of industrial training. The full year industrial training shall be consider as equivalent to total credits of 7th / 8th semester or both courses. However, such students have to comply with the following requirements for the purpose of their assessment/evaluation to be carried out by the institute;
 - a. In 7th / 8th semesters or both, each student has to submit four (4) interim/periodic written reports to the institute/department about their outputs and learning in their assignments/projects. Such periodic reports shall be required for their continuous evaluations.
 - b. After completion of each semester of the industrial training, such students have to submit the comprehensive written report to the institute/department for End semester performance Evaluation.
 - c. As a part of the above evaluation process, the students have to give presentation to the institution/department or appear in the comprehensive viva voce conducted by the institute/department.
 - 6. Formative assessment for each theory subject shall be done as per the following.

7. Summer term facility for students

For all students an additional make-up semester facility, known as summer quarter, is tentatively conducted during May-June. Makeup classes are conducted for all subjects of both even and odd semesters.

Students opting for such makeup classes shall have to pay Rs.3000/- only per Semester towards such classes (irrespective of the no. of subjects) over and above the registration fees.

Eligibility Criterion:

- 1) The students falling short of attendance in the preceding semesters (i.e. less than 75%)
- II) The students who failed in the end term examinations of the preceding semesters.
- III) The students who failed to appear at the examinations of the preceding semesters on Medical ground with submission of valid medical certificates (with regards to serious illness of himself or a calamity in the family).
- IV) The students who fall short of attendance in the preceding semesters must compensate by attending makeup classes conducted during the summer quarter and maintain attendance criteria as applicable for regular classes to be able to appear at the examinations of the summer quarter.

Attendance defaulter in Summer Quarter will attend classes either during regular semester exams/ Summer Quarter exams next year.

The grade secured by a student in a subject in the examinations of the summer quarter who has been debarred/found not eligible to appear in the Regular Examination in that subject shall be downgraded/degraded by one grade except the case when the secured grade is D (Which will remain as it is in the final calculation of SPI and CPI).

- 8. <u>During Summer Quarter</u>, one internal Examination of Maximum 40 Marks and of duration 2hrs shall be conducted for each subject. The question shall be from the entire syllabus and there will be 40 <u>objective type</u> questions. A student shall be awarded a maximum of 16 marks in this exam. Any student who had secured failed grade in a subject and obtained less than 16 in the formative assessment component in any theory subject can appear in the test. Information on Internal marks may be obtained from the Examination Cell.
